The Vendor has absolute right to change the closing date and/or time of the tender in respect of all or any of the specified residential properties from time to time by amending and/or issuing Sales Arrangements. The Vendor reserves the right, at any time before the Tender Closing Date and Time, to accept any tender submitted.
